As lawful consideration for being permitted to participate on such trip(s), I HEREBY RELEASE AND DISCHARGE EARTHBOUND ADVENTURES, INC. AND ITS EMPLOYEES OR ASSOCIATES FROM ALL ACTIONS, CLAIMS, OR DEMANDS FOR DAMAGES RESULTING FROM MY PARTICIPATION IN THE TRIP (S). I verify this statement by placing my initials here:

I agree that the foregoing obligation shall be binding upon me personally, as well as upon all members of my family including any minors under the age of 21 accompanying me, my heirs, executors, administrators, assigns, and legal representatives; it being my intention to fully assume all the risk of travel and to release EBA from liability to the maximum extent of the law. I understand that all reservations are subject to acceptance by EBA and upon acceptance shall be deemed to have been entered into and to be performed in EVANSTON, ILLINOIS COUNTY OF COOK. In the unlikely event a legal dispute should arise involving any subject matter whatsoever, I agree that the following conditions will apply: a) the dispute shall be settled by binding arbitration through the American Arbitration Association at CHICAGO, ILLINOIS; b) the dispute will be governed by ILLINOIS law; and c) the maximum amount of recovery to which I will be entitled under any and all circumstances will be the land cost of my trip with EBA. I agree to the use of photographic or film images taken of me and/or my family members on any EBA trip for use by EBA for promotional and/or commercial purposes. I further acknowledge that payment to EBA represents an acceptance of these conditions and those in EBA Terms & Conditions, in which I have noted EBA cancellation & refund policies, and agree to all stated conditions set forth there within. I am aware that this is a release of liability and a contract between EARTHBOUND ADVENTURES, INC. and myself and sign it of my own free will.
